5. The Participant consents to the Territory or its nominees adapting, altering, modifying or editing any Recording or Photograph including to make it suitable for publication, communication, broadcast or transmission.
6. Neither the Territory or its nominees will be obliged to use the Recordings, transcripts or Photographs.

## Why is the Territory collecting this information?

This consent form also collects names and contact details of the subject(s) of the Photograph/Recording and, if relevant, their parent or guardian. We use these details to be able to identify who is in the Photograph/Recording, to let you know how the Photograph/Recording is used, and for record-keeping purposes associated with use of the Photograph/Recording. We will not use your contact details for any other purpose.

We may publish your name in conjunction with the Photograph/Recording. If you provide your child's name, this may also be published in conjunction with the Photograph/Recording.

We will not otherwise disclose the contact details you have provided unless you consent, or we are required or authorised by law (including the Privacy Act 1988) to do so.
